
#### 1. Appointment of Scrutinizer

I was appointed as the Scrutinizer for the remote e-Voting as well as Poll conducted at the 143<sup>rd</sup> Annual General Meeting (143<sup>rd</sup> AGM) of Joonktollee Tea & Industries Limited (hereinafter referred to as the Company) held on Thursday, 31<sup>st</sup> August, 2017 at 10.30 a.m. at Shripati Singhania Hall, Rotary Sadan, 94/2, Chowringhee Road, Kolkata – 700 020.

The Management of the Company is responsible to ensure compliance with the requirements of the relevant provisions of (i) The Companies Act, 2013 and the Rules made thereunder; (ii) the SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015 and (iii) Secretarial Standard – 2 on General Meetings issued by the Institute of Company Secretaries of India, relating to the Poll including voting by electronic means (remote e-Voting). My responsibility as a Scrutinizer is restricted to give a Consolidated Report on the votes cast by the members for the resolutions contained in the Notice dated Thursday, 11th May, 2017.

#### 2. <u>Dispatch of Notice convening the Meeting</u>

The Company on the basis of the Register of Members and the List of Beneficiary Owners made available by the National Securities Depository Limited (NSDL) and Central Depository Services (India) Limited (CDSL), completed dispatch of the Notice of the AGM as under:-





- On 4<sup>th</sup> August, 2017 by email to 1648 members who had registered their e-mail ids with the Company/Depositories/Registrar.
- On 5<sup>th</sup> August, 2017 by Registered Post to 2794 members in physical form.

The Public Advertisement with respect to dispatch of notices and conducting of voting through electronic means was published in an English newspaper "The Echo of India" and in a Bengali newspaper "Arthik Lipi" having wide circulation, in their respective editions dated Sunday, 6th August, 2017.

#### 3. <u>Cut-off date</u>

The Voting rights were reckoned as on Thursday, 24th August, 2017, being the Cut-off date for the purpose of deciding the entitlements of members at the remote e-Voting and poll at the meeting.

## 4. Remote e-Voting

4.1 Agency:

The Company appointed Central Depository Services (India) Limited (CDSL) as the agency for providing the remote e-Voting platform.

4.2 Remote e-Voting

Remote e-Voting platform was open from 09:00 a.m. on Monday, 28<sup>th</sup> August, 2017 to 05:00 p.m. on Wednesday, 30<sup>th</sup> August, 2017 and members were required to cast their votes electronically conveying their assent or dissent in respect of the Ordinary Resolutions, on the e-Voting platform provided by CDSL.

4.3 The Corporate members had provided copy of the resolution passed at their Board of Directors Meeting for authorization to exercise their votes through e-Voting.

## 5. <u>Voting through Poll at the AGM:</u>

The Company had provided the facility for voting through Poll at the AGM and members, who have not cast their vote by remote e-Voting were allowed to exercise their right to vote at the meeting.

The polling papers in Form MGT-12 as per Section 109(5) of the Companies Act, 2013 and rule 21(1)(c) of the Companies (Management and Administration) Rules, 2014 were distributed to the shareholders present. The shareholders casted their votes in the ballot box kept at convenient place in the venue.

#### 6. <u>Counting Process:</u>

- On completion of voting the locked ballot box was subsequently opened by me and the poll papers were diligently scrutinized. The poll papers were reconciled with the records maintained by the Registrar and Share Transfer Agents of the Company and the authorizations / proxies lodged with the Company.
- 6.2 Five poll papers which were found defective have been treated as invalid and kept separately.
- The votes cast through remote e-Voting were unblocked on Thursday, 31st August, 2017 around 12 Noon in the presence of two witnesses namely Miss. Nikita Sharma and Mrs. Premlata Soni who are not in the employment of the Company.




