Subject: Passing of Special Resolution through Postal Ballot/ E-Voting in accordance with the provisions of Section 110 and other applicable provisions of the Companies Act, 2013 ("Act, 2013") read with Rule 22 of the Companies (Management & Administration) Rules, 2014 ("Rules") (including any statutory modification, amendment to or reenactment thereof) – Report on E-Voting and Postal Ballots received manually.

Dear Sir,

- 1. I, Sweety Kapoor, Practising Company Secretary, holding Membership Number FCS-6410 and Certificate of Practice Number 5738, was appointed as Scrutinizer by the Board of Directors ("The Board") of Joonktollee Tea and Industries Limited ("The Company) at their meeting held on 6th November, 2015 for the purpose of scrutinizing the voting by Postal Ballot & e-voting in respect of passing of the resolution contained in the Postal Ballot Notice dt.6th November, 2015.
- 2. The Company engaged Central Depository Services (India) Limited ("CDSL") as the Service Provider for extending the facility of electronic voting to the shareholders of the Company. The Service Provider provided a system for recording the votes of the Shareholders electronically on the resolution mentioned in the notice dated 6th November, 2015 sought to be transacted through postal ballot. Central Depository Services (India) Limited ("CDSL") had set up e-voting facility on their website: www.evotingindia.com. The Company had uploaded the item of the business to be transacted to cast their vote through e-voting.
- 3. As on the cut-off date, there were 4,767 Shareholders of the Company. The Postal Ballot Notice alongwith self addressed pre-paid postage envelopes were sent in physical form to 3,110 Shareholders and through email to 1,657 Shareholders.
- 4. The Postal Ballot Notice dt. 6th November,2015 contained the detailed procedure to be followed by the shareholders who were desirous of casting their votes electronically as provided in the Rule 20 of the Companies (Management and Administration) Rules, 2014.
- 5. The e-voting facility was kept open from 3rd December, 2015 @ 9.00 A.M. to 2nd January, 2016 @ 5.00 P.M for 30 days.

- 6- Pursuant to Rule 20(3) (v) of Companies (Management and Administration) Rules, 2014, the Company also released an advertisement, which was published in Business Standard, English Newspaper dated 3rd December, 2015 and in Aajkal, Bengali Newspaper dated 3rd December, 2015.
- At the end of the voting period on 2nd January, 2016 at 5.00 P.M. the voting portal of the service provider was blocked forthwith. On 5th January, 2016 the votes cast through e. voting facility was duly unblocked by me as Scrutinizer in the presence of Mrs. Shruti Somani and Miss Semanti Putatunda who acted as the witnesses, as prescribed in sub rule 3 (xi) of said Rule 20 of the Companies (Management and Administration) Rules, 2014.
- 8. The postal ballot forms were kept under safe custody before commencing the scrutiny of such postal ballot forms.
- 9. The postal ballot forms were duly opened in my presence and scrutinized and the shareholding was matched/ confirmed with the Register of Members of the Company/ List of Beneficiaries as on 6th November, 2015. We have relied on the information provided & records maintained by the RTA of the Company in relation to details regarding number of shares & signatures.
- 10. All postal ballot forms received upto the close of working hours on 2nd January, 2016, the last date and time fixed by the Company for receipt of the forms were considered for my scrutiny. Envelopes containing postal ballot forms received after 2nd January, 2016 were not considered for my scrutiny.
- 11. Particulars of all postal ballot forms received from the shareholders and votes cast by electronic means have been maintained in a separate register in electronic mode.
- 12. During the course of scrutiny, I didn't find any defaced or mutilated ballot paper.
