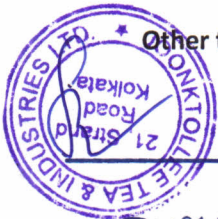
As already intimated through our letter dated December 16, 2021, The Rights Issue Committee of the Board of Directors of the Company had on December 16, 2021 approved the following:
